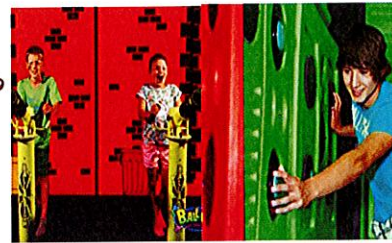
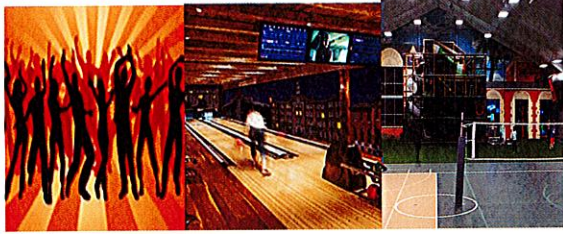

SCHOOL EVENT WAIVER

**WAIVER, RELEASE AND INDEMNITY (the "Waiver").**

FOR VALUE RECEIVED, and in consideration of the privilege of using the facilities, equipment and/or services of Elite Sports Club - \_River Glen\_\_ I, on behalf of myself and on behalf of my minor child, children or ward(s) (each of the foregoing is referred to herein as a "Participant"), acknowledge and voluntarily **assume full responsibility for the risks** inherent to a Participant's use of the Club's facilities, equipment and/or services, and accept the possibility and risk of serious personal injury and/or property damage associated with such use, including permanent disability and death, and the severe social and economic losses that might result not only from a Participant's acts or omissions but the action or inaction of others (other than the reckless or intentional conduct of others).

I, on behalf of myself and on behalf of my minor child, children or ward(s), **waive and release any and all claims** (other than claims based on reckless or intentional conduct) that any Participant may have against the Club, its shareholders, directors, officers, employees and agents and their respective heirs, legal representatives, successors and assigns (together, the "Released Parties), and **agree not to sue** any of the Released Parties for any losses, damages or expenses which arise out of, result from or relate in any manner to a Participant's use of the Club's facilities, equipment and/or services, or the acts or omissions of any of the Released Parties (other than reckless or intentional conduct).

I agree to **indemnify, defend and hold harmless** the Released Parties from and against any and all claims, liabilities, losses, damages, actions, causes of action, costs and expenses, including, without limitation, reasonable attorneys' fees and legal expenses (other than any of the foregoing that are caused by reckless or intentional conduct), that a Participant may suffer or incur as a result of the Participant's use of the Club's facilities, equipment and/or services, that third parties may suffer or incur as a result of a Participant's use of the Club's facilities, equipment and/or services, or any of the Released Parties may suffer or incur in defending any claims arising from or in connection with a Participant's use of the Club's facilities, equipment and/or services.

I agree to be responsible for any damage to the Club's facilities or equipment which is attributed to my child, children or ward(s).

BY PLACING MY INITIALS IN THE AREA FOLLOWING THIS PARAGRAPH, I ACKNOWLEDGE, AGREE AND REPRESENT THAT I HAVE BEEN GIVEN AN OPPORTUNITY TO ASK ANY QUESTIONS CONCERNING THIS WAIVER AND TO BARGAIN WITH THE CLUB CONCERNING THE PROVISIONS OF THIS WAIVER, THAT I HAVE VOLUNTARILY AGREED TO BE BOUND BY THIS WAIVER, AND THAT I AM WILLFULLY, KNOWINGLY AND VOLUNTARILY EXECUTING THIS WAIVER, ON BEHALF OF MYSELF AND ON BEHALF OF MY MINOR CHILD, CHILDREN OR WARD(S), IN EXCHANGE FOR THE OPPORTUNITY FOR MY CHILD, CHILDREN OR WARD(S) TO UTILIZE THE CLUB'S FACILITIES, EQUIPMENT AND/OR SERVICES. I AGREE THAT I HAVE BEEN GIVEN ADEQUATE CONSIDERATION FOR THIS WAIVER, AND UNDERSTAND THAT THE CLUB HAS RELIED UPON THIS WAIVER IN ALLOWING EACH PARTICIPANT TO USE THE CLUB'S FACILITIES, EQUIPMENT AND/OR SERVICES.
